Students will resume standard scheduling unless there are changes to requirements based on the health status of the region. Best practices are regulated by CDC and NJDOE regulations and will change accordingly. There will be limited sharing of communal materials, students will have individual materials and laptops assigned to them.

3) Handwashing and respiratory etiquette (460 of 1000 maximum characters used)

Students and staff will continue to regularly wash hands throughout the day and before and after meals. The school will continue to provide hand sanitizer stations throughout the building. Classrooms without sinks will also be provided with hand sanitizer. Staff will review proper cleanliness protocols with students at the beginning of the school year and as needed. Best practices are regulated by CDC

4) Cleaning and maintaining healthy facilities, including improving ventilation (799 of 1000 maximum characters used)

The school has an in-house cleaning crew employed by our school. There will be two cleaning shifts (day & evening). As part of the cleaning effort, the cleaning crew will display enhanced and intensive daily cleaning efforts as recommended by CDC and NJ DOH regarding COVID-19 and all health concerns. In addition, upgraded cleaning products to disinfect will be administered by the cleaning staff.
